Thank you for your FoI request to Downing College concerning student intermissions. I can provide the following figures for these two academic years. Most reasons for intermitting were broadly down to medical reasons and any detail beyond this is not usually specified.

Undergraduate intermissions:

- 2018/19 and 2019/20: 16 total

Postgraduate intermissions:

Please note, the numbers are taken from CamSIS, the central student record system, but this does not include those postgraduate courses (e.g. PGCE) where a student does not apply via the central system.

21-04 – Maitland Robinson Library – missing books

I am writing to you under the Freedom of Information Act 2000 to request the following information from Downing College about the Maitland Robinson Library:

1. How many books have been reported missing by undergraduates, postgraduates, staff and Fellows (or anyone else who is able to borrow books from the library), for the years 2017, 2018, 2019 and 2020. Please break this information down by year.

We do not believe there is a significant problem with missing library books. Books can sometimes be missing as they are misplaced, and therefore a book is only declared as finally lost if library staff cannot locate it for three years. Library staff undertake regular stocktaking, and for 2017 eleven books were declared as missing and in 2018 this figure was eight. I cannot provide you with a figure for 2019, as due to extensive Library renovations there was no stocktaking, and also for 2020 due to the pandemic.

2. How many of these books were reported stolen and how many were reported lost?

We do not have a category for reporting stolen books, but in 2017 two books were declared as lost and in 2018 it was one book. This library treats a book as newly lost after it has been apparently missing over the duration of three years. It is declared 'lost' when it is still missing after three years.

3. From which subjects were the most missing books each year?

2017: four books were newly missing from MML (Modern & Medieval Languages) areas; three books from the combined area of Natural Sciences with Medical & Veterinary Sciences Tripos; also a single book was missing from each of these tripos areas: English, Classics, Law, Social & Political Sciences.

2018: three History tripos books were newly missing; also a single book from each of these tripos areas: History of Art, Land Economy, Social & Political Sciences, Medical Sciences, and Archaeology.

4. What was the total amount of money that the library or Downing College received for missing books for the years 2017, 2018, 2019 and 2020? Please break this information down by year.

The Library doesn't have a figure directly allocated for this. Missing or lost books are not seen as a source of remuneration for the Library.

5. a) Did Downing College or the Maitland Robinson Library need to cover the cost of any of the books if they were not replaced or paid for by the students/staff/Fellows? Please specify where the money to replace these books comes from, and whether it is the library or the college that pays for this.

Students, staff or Fellows are not invited to replace missing or lost books themselves (unless it is fully agreed by the student that they have lost a book and a charge is made on the student's bill). If books are found to be genuinely lost, it is at the discretion of the College Librarian who does the acquisitions to acquire alternative or new copies of missing books, and the College Librarian uses the acquisitions budget of the library to acquire books.

b) If Downing College or the Maitland Robinson Library had to pay for any of the lost/stolen books, what did this cost amount to?

There is no separate accounting for additional copies of missing books or seemingly lost books.

6. What was the most expensive book that had to be replaced either by Downing College, the Maitland Robinson Library or by a student?

Since 2017: *Commercial Real Estate Analysis and Investments* by David M Geltner and Norman G Miller. This book could only be replaced second-hand at close to double its original retail price, including postage.

21-05 – Student counselling

Concerning your last question, Downing has recently appointed Ms Kate Daniels as the Head of Wellbeing. This role has responsibility for supporting the wellbeing of all Downing students. In addition to direct engagement with individual students on their welfare and wellbeing issues, the post holder will have oversight of strategic planning and implementation of courses, programmes and activities in collaboration with others (such as the College Nurses, Chaplain and Tutors) with pastoral responsibilities. Going forward, the post holder will oversee a programme of welfare-focused activity and structured support throughout the calendar year for both undergraduate and postgraduate students.

Please be advised that the College has engaged the services of an investment manager (Partners Capital) whose terms of business include a requirement that the College must not disclose any information in relation to their business or other matters of a confidential nature of which it may be made aware during the period of engagement. Furthermore, that requirement is binding on the College and the disclosure of information would constitute a breach of confidence and be actionable by the investment manager. The information is therefore exempt under section 41 (Information provided in confidence) of the Freedom of Information Act.

ANS: Downing policy was in line with national guidance with inter-household mixing permitted. The only place it was published was on the College website. The text below was published on September 17th 2020 and then updated on 5th November 2020.

#StaySafeDowningCollege

We are determined that Downing College will be a safe and secure environment.

The safety of the College, its students, and staff is best assured when all members of the community work together in a spirit of shared concern. The Collegiate University has developed a clear and comprehensive approach to managing the risks associated with COVID-19. You should familiarise yourself with all of the measures and expectations that are involved.

The University and Colleges expect all students to abide by these key principles:

- Minimise the risks of virus transmission in all aspects of your life.*
- Limit contact with other people not in your household.*
- Observe social distancing practices when you go out, keeping at least 2 metres apart wherever possible and taking other precautions, such as wearing a face covering, if it is not possible to stay 2 metres apart.*
- Sanitise or wash your hands regularly.*
- Do not leave home if you, or anyone you live with, has symptoms (if you do have symptoms please call the Porters immediately, who will be able to advise you.)*

Committed to Community Wellbeing

In acknowledgement of our commitment to each other and to the wider community, the College Fellowship, staff and current residents have all signed up to the College's Community Agreement .

All students will receive an email together with a set of documents relating to site safety, which must be read and acknowledged online prior to visiting the College. These are:

- A letter from the Senior Tutor and Dean to Students coming into residence.*
- The College Community Agreement.*
- The Risk Assessment for visitors to the College.*
- The Risk Assessment for students in residence. (residential students only)*
- The Residential Housekeeping Protocol. (residential students only)*

Working together and playing together Household Groups in the College environment

Residential students will be living in College in Household Groups. Non-resident students will also be effectively living in households either by themselves or with others.

When in College buildings and grounds, and around the University and City in general, it is essential that you follow the current regulations on how Household Groups should, and should not, interact. The Collegiate University guidance on gathering in social groups can be read [here](#).

- Within your Household, you do not need to observe social distance or wear a face covering. However, you should have a discussion with other members of your Household to ascertain everyone's feelings regarding the COVID situation and the degree of risk, with the parameters set by law, that they are prepared to accept. The College would strongly recommend following COVID-safe practices as far as practical, even within the Household spaces. You may find that extra cleaning or 'Household rules' make some people feel more secure than they might do otherwise.*
- The current University advice does not support the formation of 'support bubbles' to extend residential student Household Groups. This decision has been taken in order to avoid potential conflict or social pressure within the Household Group to 'bubble' with a particular friend or partner of a Group member. Residential Household Groups are not permitted to form 'bubbles' without permission from the Senior Tutor.*
- When meeting others not in your Household Group under any circumstances, COVID-safe behaviour is required.*
- You may meet people not in your Household group in a group of up to six people from different households. Social distancing must be observed at all times.*

Guests in College

- College members are permitted to bring guests into College as long as COVID-safe rules are followed.*
- If you are meeting in your Household space, you should agree, in advance, with other members of your Household which guests will come and when they will visit. No student should be put in the position of arriving home to find a guest in their Household whom they were not expecting.*
- The maximum number of people in the Household space at any one time, including guests, cannot exceed 6. This is a legal requirement.*
- The only exception to this rule is when the Household comprises more than 6 people in which case, all Household members can be together.*
- As soon as a guest is in the Household space, the total number of people gathered can be no more than 6.*
- Overnight guests should be agreed in advance with other members of the Household Group and the guest and host must follow normal College guest rules, including signing in the guest.*

Thank you for your FoI request to Downing College concerning H100 Engineering Admissions Statistics 2019-2021. I can provide you with data for 2019 and 2020, but not for 2021 as we are still completing the current admissions round. Also, I can only provide limited data for successful candidates due to the small number of offer holders.

Please be advised that in 2019 there were 59 home applications to study H100 Engineering and 40 students were interviewed (two interviews each). Eight of the interviewees were subsequently offered a place at Downing. The scores are as follows:

- Unsuccessful applicants

Following the guidance provided by the Information Commissioner's Office when reporting small numbers* I can confirm that we have 0-5 incidents on record each year since 2017 to the present. As Downing is a small community there is a risk that an individual case could be identified (section 40(2) exemption, personal information) if any details were published. I can confirm though that we do take any complaint of alleged sexual assault or harassment very seriously; action is taken, any matters are investigated and alleged perpetrators interviewed and appropriate measures taken. Furthermore, no student has been expelled, or staff dismissed, from the College as a result of a sexual assault/harassment complaint, and the College has not needed to refer any matters to the police.

*The Information Commissioner recommended the use of "0-5" (or fewer than 5) in 2017 on the same topic; please see <https://ico.org.uk/media/action-weve-taken/decision-notices/2017/2172649/fs50682996.pdf>. Response

Thank you for your FoI request to Downing College concerning student counselling.

We do not hold the information to answer your questions as students self-refer for counselling, whether this is with the University Counselling Service or with our College Counsellors (who are themselves UCS workers). Furthermore, owing to the confidential nature of counselling, it is not the practice of the UCS to share information with the College. As such, we would have no knowledge of who has accessed counselling or any student's reason for doing so. However, may I suggest that you contact the UCS who may be able to provide you with figures to answer your first question.

Under the Act, I am requesting the release of the following information:

- 1) The number of reports of sexual assault and harassment that have been received by your college in the academic years 2018-2019, 2019-2020 and 2020-2021, with figures on sexual assault and figures on sexual harassment presented separately

- 2) The gender breakdown of the complainants and respondents in cases of sexual assault and harassment reported to your college in the academic years 2018-2019, 2019-2020 and 2020-2021
- 3) The number of complainants of sexual assault or harassment to your college who were BAME in the academic years 2018-2019, 2019-2020 and 2020-2021
- 4) A breakdown of how many cases of sexual assault and harassment reported to your college were reportedly committed by someone the complainant knew or was in a relationship with in the academic years 2018-2019, 2019-2020 and 2020-2021
- 5) A breakdown of the different outcomes of cases of sexual assault and harassment reported to your college in the academic years 2018-2019, 2019-2020 and 2020-2021
- 6) The number of college staff members who were reported for sexual assault or harassment to your college in the academic years 2018-2019, 2019-2020 and 2020-2021, with a breakdown of the types of staff implicated (Fellows and teaching staff, catering staff, security staff etc.) and a breakdown of the number of complainants in these cases who were students and who were fellow staff members
- 7) A breakdown of the outcomes of cases where staff were reported to the College for sexual assault or harassment in the academic years 2018-2019, 2019-2020 and 2020-2021.

Response

Thank you for your FoI request to Downing College concerning sexual assault and harassment since 2018.

Following the guidance provided by the Information Commissioner's Office when reporting small numbers* I can confirm that we have 0-5 incidents on record each year since 2018 to the present. As Downing is a small community there is a risk that an individual case could be identified (section 40(2) exemption, personal information) if any details were published. I can confirm though that we do take any complaint of alleged sexual assault or harassment very seriously; action is taken, any matters are investigated and alleged perpetrators interviewed and appropriate measures taken. Furthermore, no student has been expelled, or staff dismissed, from the College as a result of a sexual assault/harassment complaint, and the College has not needed to refer any matters to the police.

*The Information Commissioner recommended the use of "0-5" (or fewer than 5) in 2017 on the same topic; please see <https://ico.org.uk/media/action-weve-taken/decision-notices/2017/2172649/fs50682996.pdf>. The case concerned King's College in Cambridge and when discussing the merits of the argument about small numbers changing over time, the Information Commissioner recommended the use of "0-5" in this case, stating (para 28):

The Commissioner also notes that the phrase 'less than 5' is often used in the suppression of the individual numbers of '0, 1,2,3,4 and 5'. Therefore, it would be possible for the College to respond to the third request dated 29 March 2017 using the 'less than 5' response even if the response for the current academic year is the same 'nil' response as the previous five years.
